

Government Grant Guide





How much is Grant?

The Department for Education (DfE) is offering a grant of £1,200 for eligible state-funded schools and colleges in England to train a Senior Mental Health Lead to develop and implement a whole school or college approach to mental health and wellbeing. It is a part of the government's commitment to offer this training to all eligible schools and colleges by 2025.





What is the grant used for?

The Senior Mental Health Leads training courses are suitable for Mental Health Leads that are just starting their journey, those that are familiar with their role, and leads that have previously engaged in comprehensive Senior Mental Health Leadership training. The training covers the 8 principles recommended by Public Health England, it offers practical resources and the space to network.



Who is eligible for the grant?

State-funded schools, primary schools/secondary schools, alternative provisions, academies, and colleges in England; the setting must be committed to develop or implement a whole school/college approach to mental health.

Identify a Senior Mental Health Lead to oversee your whole school approach. If your SMHL is not a member of your school or college Senior Leadership Team, you will need to consider whether the individual has the authority, capacity, and support to influence and lead strategic change within the setting.

The Senior Mental Health Lead training grant is intended to develop a single person (a strategic lead) in each setting; to learn everything they need to lead the implementation of an effective and sustainable whole school or college approach. Training for additional staff cannot be paid for through this grant, and only one grant will be available per school or college. However, the school can self-fund additional training places.
